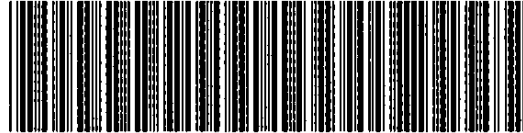


**FIRST:** The date of filing of the articles of organization was October 26, 2004.
