### ARTICLES OF ORGANIZATION

**OF** 

#### E-LAWYER.COM, L.L.C.

The undersigned, for the purpose of performing a limited liability company under the Florida Limited Company Act, F.S. Chapter 608, hereby make, acknowledge, and file the following Articles of Organization.

#### ARTICLE I. NAME

The name of the limited liability company shall be E-Lawyer.com, L.L.C.

#### **ARTICLE IL ADDRESS**
