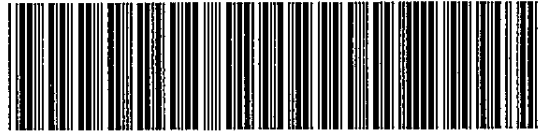

**ARTICLE VII - Admission of Additional Members**


The members of the Company shall have the right to admit additional members by the unanimous consent of, and subject to the terms and conditions of, all the remaining members.
