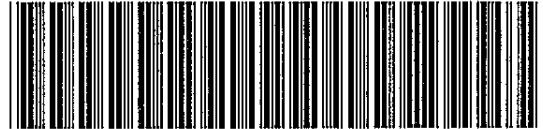

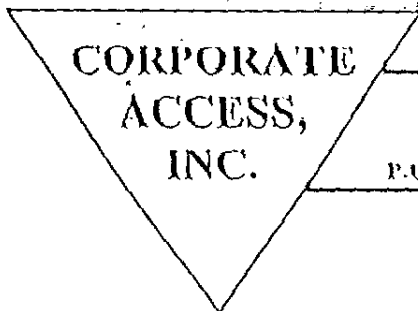


**ARTICLE IV

AMENDMENT**




