## Around the World Moving & Storage, LLC

### A Florida Limited Liability Company

- 1. Name. The name of this limited liability company is Around the World Moving & Storage, LLC (the "Company"), and it shall be formed as a Florida limited liability company under Chapter 608, Florida Statutes.
