#### ARTICLES OF MERGER

OF

#### 1736 CAROTHERS PARKWAY, LLC AND

#### NORTHPOINT 45TH, LLC

Pursuant to applicable provisions of the Tennessee Revised Limited Liability Company Act, Tennessee Code Annotated § 48-249-101 et seq. (the "Tennessee Act") and pursuant to Fla. Stat. §605.1021, et. seq. (the "Florida Act"), the undersigned, on behalf of Northpoint 45<sup>th</sup>, LLC, a Florida limited liability company, and 1736 Carothers Parkway, LLC, a Tennessee limited liability company, hereby adopt and submit the following Articles of Merger and hereby state as follows:

- 6. 1736 Carothers Parkway certifies that its participation in the Merger was duly authorized as required by the law of the State of Tennessee.
- 7. The Plan of Merger is on file at the principal place of business of 1736 Carothers Parkway located at 150 Third Avenue South, Suite 1600, Nashville, Tennessee 37201.
- 8. The mailing address for service of process for the surviving entity is 150 3rd Avenue South, Suite 1600 Nashville, Tennessee 37201.
- 9. The surviving entity has agreed to pay to any member of Northpoint with appraisal rights the amount to which such member is entitled under Florida law.
