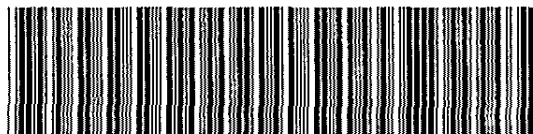

NAME
