THIRD: Articles of Correction were filed on November 11, 2004, correcting the statement as follows:

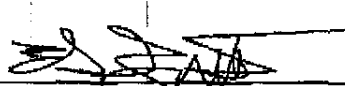
The name of the Company is Gulf Coast Ice House Distributors, LLC.

6. Amendment. These Articles of Organization may be amended in the manner provided in the Operating Agreement of the Company.

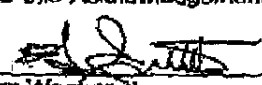
