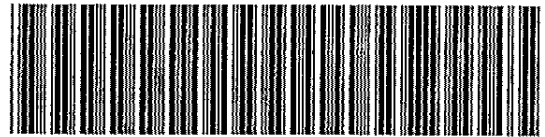



Beemer & Associates III, Ltd. was formed in the State of Florida on January 30, 1996.


**ARTICLE III**
