ARTICLES OF ORGANIZATION

OF

The undersigned, for the purpose of forming a limited liability company under the Florida Limited Liability Company Act, F.S. Chapter 608, hereby make, acknowledge, and file the following Articles of Organization.

ARTICLE I -- NAME

The name of the limited liability company shall be COASTAL MEDIA GROUP, LLC ("Company").

ARTICLE II -- ADDRESS

The mailing address and street address of the principal office of the company shall be 3001 NE 46th Street, Lighthouse Point, Florida 33064.

ARTICLE III -- DURATION

The company shall commence its existence on the date these articles of organization are filed by the Florida Department of State. The company's existence shall be perpetual unless the company is earlier dissolved as provided in these articles of organization or the operating agreement or regulations of the company.

ARTICLE IV -- REGISTERED OFFICE AND AGENT

The name and street address of the registered office and agent of the company in the State of Florida is Regina Castronovo, 3001 NE 46th Street, Lighthouse Point, Florida 33064.

ARTICLE V -- ADMISSION OF NEW MEMBERS

No additional members shall be admitted to the company except with the unanimous written consent of all the members of the company and on such terms and conditions as shall be determined by all the members.

ARTICLE VI -- TERMINATION OF EXISTENCE

The members shall have the right to continue the business on the death, retirement,

resignation, expulsion, bankruptcy, or dissolution of a member or the occurrence of any other event which terminates the continued membership of a member in the company in the manner set forth in the operating agreement or regulations of the company.

ARTICLE VII-- MANAGEMENT

The company shall be managed in accordance with operating agreement or regulations adopted by the members for the management of the business and affairs of the company. These regulations or operating agreement may contain any provisions for the regulation, operation and management of the affairs of the company not inconsistent with law or these articles of organization.


