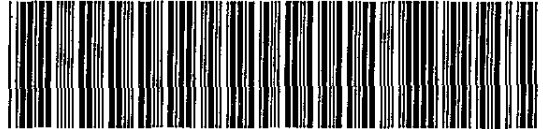

ARTICLES OF ORGANIZATION

FOR

JOHO'S WASH HOUSE, LLC

ARTICLE I - Name

The name of this limited liability company shall be JOHO'S WASH HOUSE, LLC.

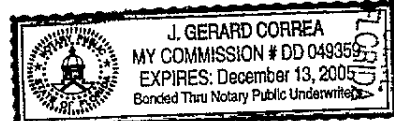
