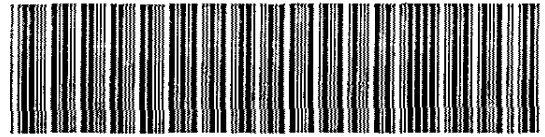

ARTICLES OF ORGANIZATION
OF FIRST IMPRESSIONS ARCHITECTURAL DESIGN, LLC.
a Florida limited liability company

ARTICLE I

NAME

The name of this limited liability company is FIRST IMPRESSIONS ARCHITECTURAL DESIGN, LLC.


