
ARTICLE VI

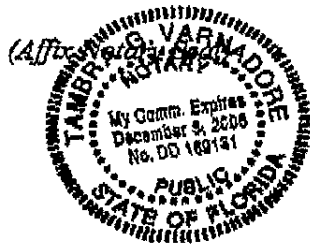



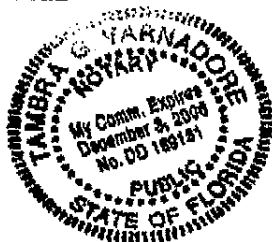
