ARTICLES OF ORGANIZATION

The undersigned, being a duly authorized representative of a Member, desiring to form climited liability company under and pursuant to the Florida Limited Liability Company Act, chapter 608, Florida Statutes, does hereby adopt the following Articles of Organization and hereby certifies:

ARTICLE I: NAME

The name of the limited liability company is TKR, LLC (the "Limited Liability Company").

ARTICLE II: ADDRESSES

The mailing address of the Limited Liability Company is 1197 - 38th Avenue NE, St. Petersburg, Florida 33704. The street address of the principal office of the Limited Liability Company is 1197 - 38th Avenue NE, St. Petersburg, Florida 33704.

ARTICLE III: DURATION
