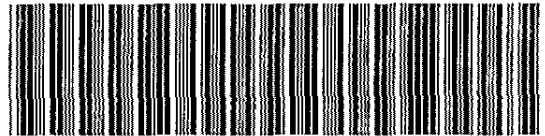


## **ARTICLE VI**


