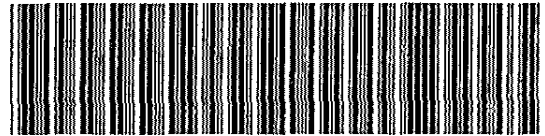

**ARTICLE I
NAME AND PRINCIPAL PLACE OF BUSINESS**

The name of the Limited Liability Company shall be DAR PO INVESTMENTS, LLC, and its principal office shall be located at 2305 Kanaka Drive, Jacksonville, State of Florida, but shall have the power of attorney to establish branch offices at any of the place or places that the members may designate.

**ARTICLE II
PURPOSE AND POWER**

In addition to the powers authorized by the laws of the State of Florida for Limited Liability Companies, the general nature of the business or businesses to be transacted, and for which the Limited Liability Company is authorized to transact shall be any and all legal business.

**ARTICLE III
EXERCISE OF POWERS**

All of the Limited Liability Company powers shall be exercised by or under the authority of, and the business and affairs of this Limited Liability Company shall be managed under the direction of, the members of this Limited Liability Company. PERIOD OF DURATION

This Limited Liability Company shall be perpetual or until voluntarily dissolved by the members.

ARTICLE VI

Additional members may be admitted to the Limited Liability Company by a majority vote of the existing members of the Limited Liability Company, according to the operating agreement passed by the members.
