The undersigned, being an authorized representative of the initial members of a limited liability company to be organized under the Florida Limited Liability Company Act, adopts and submits the following Articles of Organization for such limited liability company:

## ARTICLE I

The name of the limited liability company shall be **CORAL THREE**, **LLC**, a Florida limited liability company (the "Company").

# ARTICLE II PRINCIPAL PLACE OF BUSINESS

The mailing address and street address of the principal office of the Company shall be 27749 Forester Drive, Bonita Springs, Florida, 34134.

## ARTICLE III REGISTERED OFFICE AND REGISTERED AGENT

## ARTICLE IV ADMISSION OF MEMBERS

The members of the Company may admit new members to the Company as more fully described in and subject to the terms, conditions and requirements set forth in the Company's Operating Agreement and Regulations. Newly admitted members shall have all of the rights and privileges as set forth in the Company's Operating Agreement and Regulations.

#### ARTICLE V EFFECTIVE DATE

The Company's effective date of existence shall begin on the date of filing of these Articles.

### ARTICLE VI DURATION

The initial number of managers of the Company shall be one (1) which shall be designated, appointed or elected in accordance with the terms of the Operating Agreement and Regulations of the Company. The initial Manager shall be Craig T. Palmer, until a substitute or successor is elected or appointed in accordance with the Operating Agreement. The number of managers may be decreased or increased in accordance with the terms of the Operating Agreement and Regulations.
