**ARTICLE 1**

**NAME**

The name of this Professional Service Limited Liability Company is: Robert W. Burns, M.D., F.A.C.S., P.L.

**ARTICLE 2**

**PURPOSE**

The purpose for which this professional service limited liability company is initially organized is to engage in every phase and aspect of the practice of general surgery, rendering the same professional services to the public that a doctor, duly licensed under Florida laws is authorized to render, but such services will be rendered only through the company's officers, employees, and agents who are duly authorized under Florida laws to practice general surgery. The company also may engage in any or all lawful business which professional service limited liability companies practicing general surgery may engage in under the Florida Professional Service Limited Liability Company Act.

**DISQUALIFICATION OF MEMBERS, OFFICERS, AGENTS, AND EMPLOYEE**

If any officer, member, manager, agent or employee of this professional service limited liability company who has been rendering professional medical services to the public, becomes legally disqualified to render such services within the State or accepts employment which, pursuant to existing laws, places restrictions or limitations upon his continued rendering of such professional services, he shall sever all employment with, and financial interest in, this professional service limited liability company forthwith.

**ARTICLE 7**

**VOTING TRUSTS**

No member of this professional service limited liability company shall enter into a voting trust agreement or any other type of agreement vesting in another person the authority to exercise the voting power of any or all of his membership interest.

**ARTICLE 8**

**INDEMNIFICATION**

To the fullest extent permitted by law, this professional service limited liability company shall indemnify any person who was or is a party to any proceeding by reason of the fact that he/she is or was a manager, managing member or officer of the company or is or was serving at the request of the company as a manager, managing member, director, or officer of another limited liability company, corporation, partnership, joint venture, trust or other enterprise against liability incurred in a manner he/she reasonably believed to be in, or not opposed to, the best interests of the company and, with respect to any criminal action or proceeding, had no reasonable cause to believe his/her conduct was unlawful. The company shall reimburse each person for all costs and expenses, including, without limitation, attorneys' fees, reasonably incurred by him in connection with any such liability in the manner provided for by law or in accordance with the Operating Agreement of the company. The rights accruing to any person under the foregoing provision shall not exclude any other right to which he may be lawfully entitled, nor shall anything therein contain or restrict the right of the company to indemnify or


