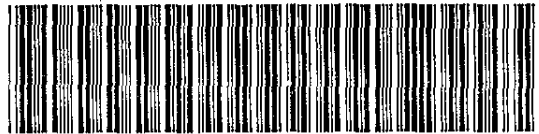



ARTICLES OF ORGANIZATION  
OF CRAWFORD & CRAWFORD INVESTMENTS, LLC.  
a Florida limited liability company

ARTICLE I

NAME

The name of this limited liability company is CRAWFORD & CRAWFORD INVESTMENTS, LLC.



