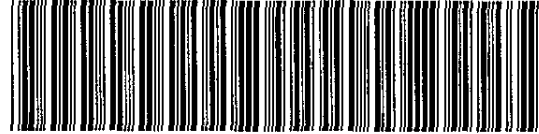

The Company is to be managed by the Manager and the name and address of the initial manager is:




