**ARTICLES OF AMENDMENT TO ARTICLES OF ORGANIZATION
OF
CORNERSTONE HALLANDALE, LLC**

The undersigned, as Vice President of CORNERSTONE HALLANDALE, LLC, a Florida limited liability company (the "Company"), desiring to amend the Articles of Organization of the Company pursuant to the terms of Chapter 608, Florida Statutes, the Florida Limited Liability Company Act (the "Act"), states as follows:

1. The current name of the Company is CORNERSTONE HALLANDALE, LLC.
2. The date of the filing of the original Articles of Organization of the Company was November 5, 2004.
3. The Articles of Incorporation of the Organization are amended by deleting Article I entitled "Name" in its entirety and inserting the following section in its place and stead:
