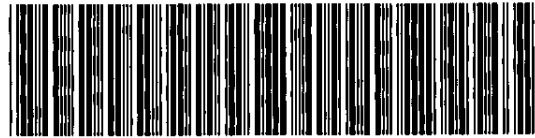

Article IV of the Articles of Organization shall be amended and restated as follows:


