Name. The name of this limited liability company is: **5TH STREET SW LLC.**



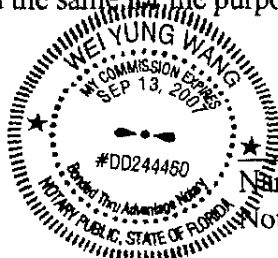


