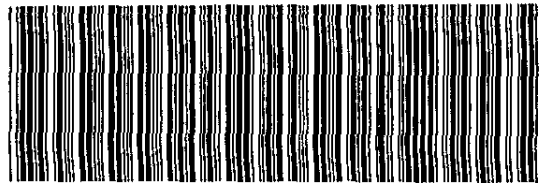

Name. The name of this limited liability company is: **8TH COURT SW LLC.**



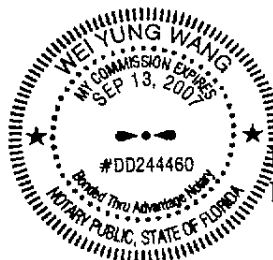


