Name. The name of this limited liability company is: 2ND STREET SW LLC.



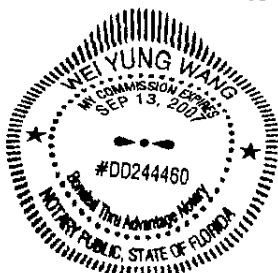
