ARTICLES OF ORGANIZATION

ARTICLES OF ORGANIZATION OF SUNNYFLOR, LLC. The undersigned certifies that the members described herein have associated themselves for the purpose of becoming a limited liability company under the laws of the State of Florida, providing for the formation, rights, privileges, and immunities of limited liability companies for profit. The undersigned further declares that the following Articles shall serve as the Charter and authority for the conduct of business of the limited liability company.

ARTICLE I NAME AND PRINCIPAL PLACE OF BUSINESS

The name of the limited liability company shall be Sunnyflor, LLC and its principal office shall be located at 2901 North River Edge Blvd., Crystal River, Florida 34428. The mailing address of the entity shall be 2901 North River Edge Blvd., Crystal River, Florida 34428. The entity shall have the power and authority to establish branch offices at any other place or places as the members may designate.
