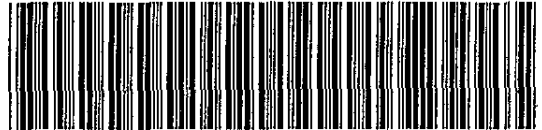



ARTICLES OF ORGANIZATION FOR
SHG-MCMEEKIN, L.L.C.

The undersigned, pursuant to the provisions of Chapter 608 of the Florida Statutes, for the purpose of forming a Limited Liability Company under the laws of the State of Florida does hereby set forth the following:

ARTICLE I - NAME OF LIMITED LIABILITY COMPANY

The name of the Limited Liability Company (the "Company") shall be SHG-MCMEEKIN LAND, L.L.C.

ARTICLE II - PRINCIPAL OFFICE AND MAILING ADDRESS
