#### ARTICLES OF ORGANIZATION

The undersigned person, acting as the organizer of KB EXCHANGE I, LLC, under the Florida Limited Liability Company Act, Chapter 608, Florida Statutes, adopts the following Articles of Organization:

#### ARTICLE I - NAME
