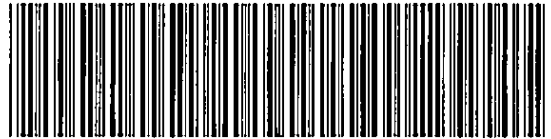

ARTICLE II: ADDRESS

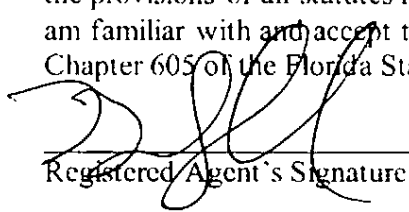
