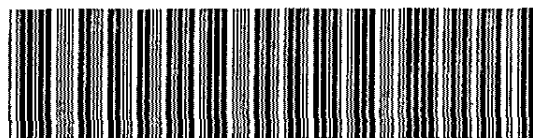

**ARTICLES OF ORGANIZATION
OF

ARTICLE I - NAME

ARTICLE X – TERMINATION OF MEMBER

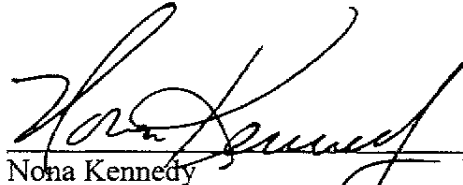

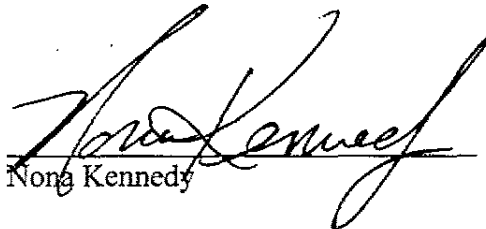
ACCEPTANCE OF REGISTERED AGENT
