Thank you for your email.

We are forwarding your address change request for STUDIO MIRAGE LLC, Florida document number L04000081267 to the proper section to be updated.

Once a fictitious name has expired, the same registration can not be made active again. In order to use the name you will need to file a new registration for the name.

A fictitious name is registered by completing an Application for Registration of Fictitious Name. Sections one through three must be completed for the registration of a fictitious name. All applications must be made on forms prescribed by the Secretary of State.

The fee to file the application for registration of a fictitious name is \$50.00. Upon registration the Division sends an acknowledgment letter stating the name registered, its registration number, and date of registration. For an additional \$10.00 a Certificate of Status can be requested, or for an additional \$30.00 a Certified Copy can be requested.

Effective July 1, 2009, the intention to register a fictitious name must be advertised at least once in a newspaper in the county in which the principal place of business will be located. Contact your newspaper for advertising information.

Forms can be downloaded from our website (select "Print Filing Forms") or requested by phone by calling (850) 245-6058. They are sometimes also available at the Clerk of the Circuit Court in counties throughout Florida. You may also register online at www.sunbiz.org. Select "Electronic Filing" and on the next page select "Fictitious Name Registration".

A fictitious name registration is for public notice. There are no ownership rights in a fictitious name and the name is not protected against use by anyone else. The same fictitious name can be filed by more than one party.
