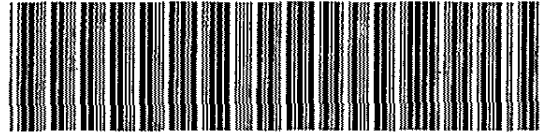

Article 1 - NAME


