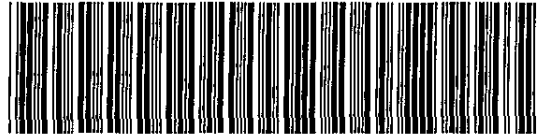

ARTICLE I. NAME

ARTICLE V. ADMISSION OF NEW MEMBERS

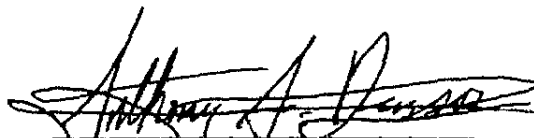

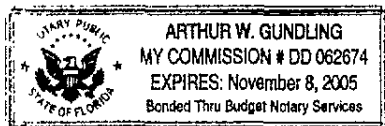

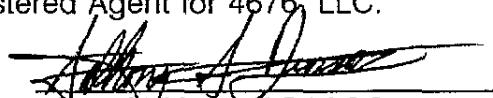
