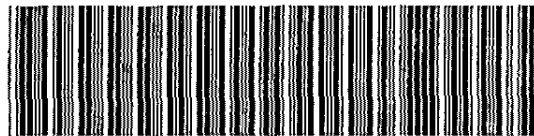

ARTICLES OF ORGANIZATION
OF
THE LAW OFFICES OF YEN T. CAM, PLLC

The undersigned, pursuant to the provisions of Chapter 608 of the Florida Statutes (the "Florida Limited Liability Company Act"), and Chapter 621 of the Florida Statutes (the "Professional Service Corporation and Limited Liability Company Act") for the purpose of forming a Professional Limited Liability Company (within the meaning of Section 621.03(3), Florida Statutes) under the laws of the State of Florida do set forth the following:

1. **NAME.**

The name of the Limited Liability Company is THE LAW OFFICES OF YEN T. CAM, PLLC (hereinafter referred to as the "Company").

2. **PERIOD OF DURATION.**

The period of duration of the Company shall be from the later of January 1, 2004, or the date of filing of these Articles of Organization, until the first to occur of the following:

- (i) The date that is seventy-five (75) years from the date of filing of the Articles of Organization with the Department of State, State of Florida; or
- (ii) Dissolution of the Company pursuant to the provisions of the Florida Limited Liability Act; or
- (iii) By the mutual written agreement of a majority in capital interest of the Members.

3. **PURPOSE.**

The purpose for which the Company is organized is to engage in and carry on the practice of law in the State of Florida and in such other states as the Company and its attorneys may be qualified to practice law, and all activities incident thereto. The Company shall have all of the powers vested in a limited liability company organized and existing by virtue of Chapter 608, Florida Statutes, and Chapter 621, Florida Statutes.

4. **ADDRESS OF PLACE OF BUSINESS.**

The mailing address and the street address of the place of business for the Company is 2310 Miranda Avenue, Tallahassee, Florida 32304. Such address may be changed from time to time as provided in the Operating Agreement.

5. **REGISTERED AGENT.**

The initial registered agent in Florida for the Company is Huy-Yen T. Cam and the initial registered office is located at 2310 Miranda Avenue, Tallahassee, Florida 32304.

6. **MEMBERS.**

The class of members designated as "Members" shall have all of the rights of members allowed under Chapter 608, Florida Statutes, and Chapter 621, Florida Statutes, and such rights, duties and obligations as may be contained in the Operating Agreement. The following persons are the initial members:

7. **CONTINUITY OF BUSINESS.**

Upon the death, retirement, resignation, expulsion, bankruptcy, or dissolution of a

Member, or the occurrence of any other event which terminates the continued membership of a Member in the Company, the business of the Company shall be continued and the Company shall not be dissolved without the prior written consent of all the remaining Members of the Company.

8. **MANAGEMENT.**

Management of the Company is reserved to its Members. The Members may elect a manager in the manner provided in the Operating Agreement. Any such Manager shall have the powers and authority expressly granted under the Operating Agreement. The Initial Manager is: Huy-Yen T. Cam, having her principal offices at 2310 Miranda Avenue, Tallahassee, Florida 32304.

9. **INDEMNIFICATION.**

Except as expressly provided otherwise in the Operating Agreement, the Company shall indemnify any Member or former Member to the full extent permitted under Florida law.
