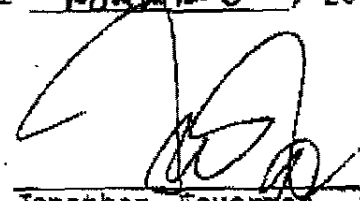
ARTICLE VI**Manager-Managed Company**
