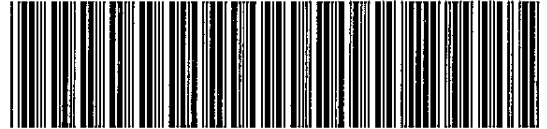

The undersigned, for the purpose of forming a limited liability company under the Florida Limited Liability Company Act, Florida Statutes Chapter 608, hereby makes, acknowledges, and files the following Articles of Organization.

**ARTICLE 1 - NAME**

The name of the limited liability company shall be **ESPRIT CATAMARANS LLC**, ("Company").

**ARTICLE 2 - ADDRESS**

The principal place of business of the Company in Florida shall be 1840 Southwest 22nd Street, 4th Floor, Miami, Florida 33145 and the mailing address shall be 415 East Calder Way, State College, Pennsylvania 16801.

**ARTICLE 3 - EFFECTIVE DATE**


