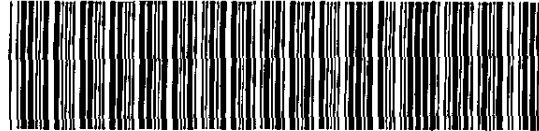

**ARTICLE V: MANAGEMENT**

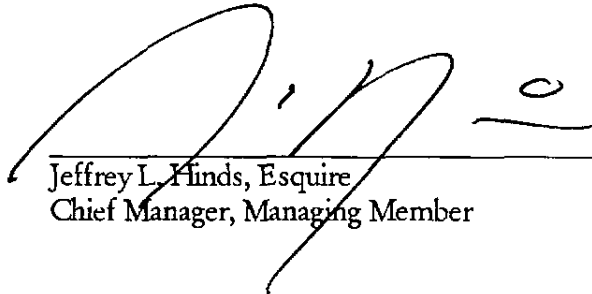
