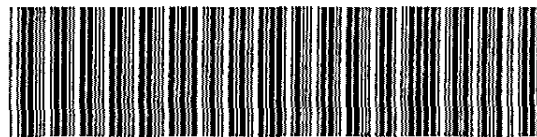

Article V

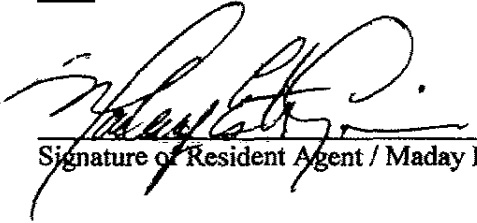
No manager or member of this Company may transfer, sell or assign its Membership Interest in the Company to any other person except as provided for in the Company's regulations and Operation Agreement.

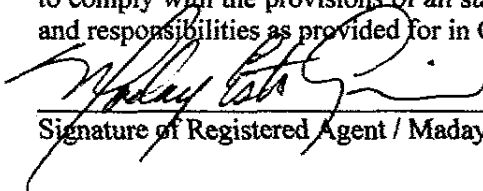
