**ARTICLES OF ORGANIZATION FOR
WORLD RETAIL CONSULTANTS, LLC.
A FLORIDA LIMITED LIABILITY COMPANY**

The undersigned, desiring to form a limited liability company under and pursuant to Florida Statute, Section 608.401 et. seq., entitled the Florida Limited Liability Company Act, does hereby adopt the following Articles of Organization for such company:

1. **NAME.** The name of this company shall be WORLD RETAIL CONSULTANTS, LLC.

2. The address of the principal office of the Company is 4875 North Federal Highway, 7th Floor, Fort Lauderdale, Florida 33308.

3. **REGISTERED AGENT AND OFFICE.** The name and street address of the initial registered agent and office for the Company is as follows: ARTHUR R. ROSENBERG, located at 4875 North Federal Highway, 7th Floor, Fort Lauderdale, Florida 33308.

Regulations adopted by the Members or by the Manager(s) may be repealed or altered, new Regulations may be adopted by the Members, and the Members may prescribe in any Regulations made by them that such Regulations may not be altered, amended or repealed by the Manager(s).


