The undersigned hereby certifies that the members named herein have associated together for the purpose of becoming a Professional Limited Liability Company under Florida Statutes Chapters 608 and 621, providing for profit and the following Articles of Organization are hereby adopted:

**ARTICLE I - NAME**

The name of the Company is **FRANK NATTER, P.L.L.C.**

**ARTICLE II - DURATION**

This Company shall begin on the effective date of filing these Articles of Organization and shall have perpetual existence unless dissolved according to law.

**ARTICLE III - BUSINESS**
