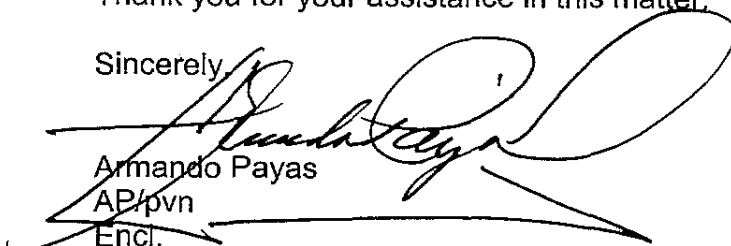

Name and Duration

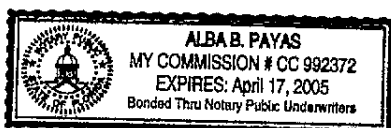
