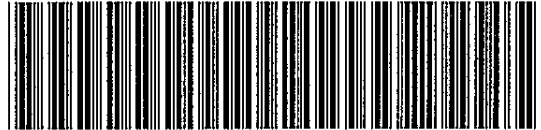



NAME


