

ARTICLES OF ORGANIZATION

OF

J&JCLENNEY, L.L.C.

The undersigned, for the purpose of forming a limited liability company under the Florida Limited Liability Company Act, F.S. Chapter 608, hereby make, acknowledge, and file the following Articles of Organization.

ARTICLE I. NAME

The name of the limited liability company shall be J & J CLENNEY, L.L.C.

ARTICLE II. ADDRESS
