# ARTICLE I

#### NAME

The name of the limited liability company is WEIGHT LOSS COACHING AND CONSULTING, LLC (the "Company").

# ARTICLE II

# ADDRESS

### ARTICLE VII

#### ADMISSION OF NEW MEMBERS
