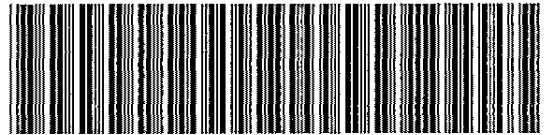

**Articles of Organization of
Jet-U-ThAir, LLC**

Article I

The name of the limited liability company ("Company") is Jet-U-ThAir, LLC.

Article II

The mailing address of the Company is 2173 South Woodland Boulevard, DeLand, Florida 32720 and street address of the Company's principal office is 2173 South Woodland Boulevard, DeLand, Florida 32720. unanimous written consent of the existing members, and the existing members shall determine the amount and nature of contributions by new members at the time the new members are admitted. The initial Member of the Company is James Brendan Hurley. His address is 2173 South Woodland Boulevard, DeLand, Florida 32720.


Article VII

The remaining members of the Company have the right to continue the business on the death, retirement, resignation, expulsion, bankruptcy, or dissolution of a Member or the occurrence of any other event which terminates the continued membership of a Member in the Company as provided in the Company's Operating Agreement.

Article VIII

The power to adopt, alter, amend, or repeal the Operating Agreement of the Company is vested entirely in the Members and any such adoption, alteration, amendment or repeal must be done by unanimous written consent of the Members.
