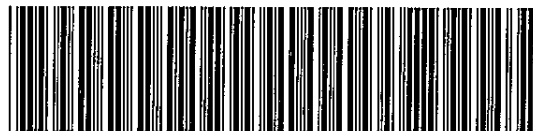

Article V. Limitation on Agency Authority of Members


Pursuant to Section 608.4235 of the Florida Statutes, no member of the Company shall be an agent of the Company solely by virtue of being a member.
