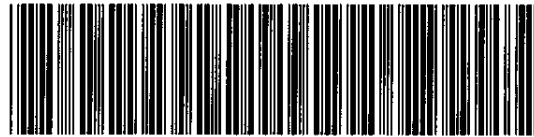

FIFTH: Pursuant to Section 608.4421, adequate provision has been made for the debts, obligations and liabilities of the Company.


SIXTH: There are no suits pending against the company in any court.
