### ARTICLES OF ORGANIZATION

OF

### HARRY FRANCIS MALLGRAVE, ARCHITECT, CHARTERED

Pursuant to the Florida Professional Service Corporation and Limited Liability Company Act and the Florida Limited Liability Company Act the undersigned, acting as organizer of a professional limited liability company, who is a duly licensed architect under the laws of the state of Florida, hereby adopts the following Articles of Organization for such Company:

#### Article I <u>Name</u>

The name of the limited liability company is Harry Francis Mallgrave, Architect, Chartered.

# Article II Company Existence

The Company's existence shall be perpetual and shall be effective upon the filing of these Articles of Organization with the Florida Department of State.

### Article III <u>Units of Equity Ownership</u>

Section A. Authorized Units of Equity Ownership. The maximum number of units of equity ownership units Harry Francis Mallgrave, Architect, Chartered is authorized to have outstanding is 1,000 units, all of which shall be identical units. None of the units of the Company may be issued to anyone who is not a duly licensed architect under the laws of the state of Florida.

Section B. First Lien. The Company shall have a first lien upon the units of any Member for any debt or liability owing by such Member to the Company.

Section C. Restrictions on Disposition of Units. No Member of this Company shall sell, transfer, convey, pledge, give, distribute or encumber any unit or units in the Company without first giving notice in writing to the Company of such intended disposition and without first securing the written approval of Members of the Company owning 100% of the then-issued and outstanding Membership Units of the Company. However, nothing contained herein shall prevent distribution by operation of law, of such unit or units, provided that in such case a

transferee shall be bound by the provisions contained in this Section the same as an original Member.

Section D. Right to Redeem Units. Without regard to any other power to purchase units of the Company as permitted by law, the Company may purchase outstanding units in an amount not to exceed its capital.

Section E. Transfer of Units of Indebted Member. If a Member shall be indebted to the Company, the Company may refuse to consent to a transfer of his units until such indebtedness is paid, provided a copy of this Section or the substance thereof is written or printed upon the Certificates representing such units.

### Article IV Registered Agent and Office

The address of the initial Registered Office of the Company is 912 Seagrape Lane, Vero Beach, FL 32963, and the name of its initial Registered Agent at such address is Harry F. Mallgrave.

### Article V Principal Office

The mailing address and street address of the principal office of the Company is 912 Seagrape Lane, Vero Beach, FL 32963.

# Article VI Agent for Service of Process

The Department Of State of the State of Florida is designated as the agent of the Company upon whom process in any action or proceeding against it may be served. The address to which the Department Of State shall mail a copy of process in any action or proceeding against the Company which may be served upon it is 912 Seagrape Lane, Vero Beach, FL 32963.

#### Article VII Organizer

The name and address of the organizer, who is a duly licensed architect under the laws of the state of Florida, is:

### Article VIII Purpose and Power

The Company shall be formed for the purpose of engaging in every phase and aspect of the business of rendering the same professional services to the public that an architect, duly licensed under the laws of the State of Florida, is authorized to render, but such professional services shall be rendered only through officers, employees and agents who are duly licensed under the laws of the State of Florida to practice architecture therein. The Company may furnish or supply by contract architectural services requiring application of the science, art, or profession of planning sites and of planning or designing buildings or architectural structures and their related facilities by and under the direct supervision of certificated architects and other licensed personnel; to do consultation, investigation, evaluation, planning, design, preparation of instruments of service such as drawings and specifications; and to supervise construction insofar as customarily performed by architects. In connection with the above-mentioned purposes, the Company shall have the power to invest its funds in real property and securities, to acquire, own, and dispose of real and personal property, and to do all other acts incidental and necessary to the accomplishment of the foregoing purposes, to the extent permitted under the Florida Limited Liability Company Act.

# Article IX Voting Trusts

No Member of the Company shall enter into a voting trust agreement or any other type of agreement vesting in another person the authority to exercise the voting power of any or all of such Member's units.

# Article X Repurchase Of Membership Units

If any Member shall die or no longer be a duly licensed architect under the laws of the state of Florida, such Member's units shall immediately be purchased by the Company

#### Article XI Management

The Company is to be managed by a Member-Manager or Member-Managers. The Member-Manager(s) of the Company shall be named pursuant to the Operating Agreement of the Company. The initial Member-Manager of the Company, who shall serve as such until its successor is elected and shall qualify, is:

#### Article XII Indemnification

The Company shall indemnify any Member and/or Member-Manager who is or was a party, or who is threatened to be made a party, to any threatened, pending or completed action, suit or proceeding, whether civil, criminal, administrative or investigative, including all appeals, by reason of the fact that such Member and/or Member-Manager is or was a Member, Officer or employee of the Company, or is or was serving at the request of the Company as a director, trustee, officer or employee of another limited liability company, corporation, partnership, joint venture, trust or other enterprise, against any and all expenses (including reasonable attorneys' fees), judgments, decrees, fines, penalties and amounts paid in settlement, which were actually and reasonably incurred by such Member and/or Member-Manager in connection with such action, suit or proceeding. The Company shall not indemnify any Member and/or Member-Manager in the event of (i) a breach of such Member and/or Member-Manager's duty of loyalty to the Company or its Members, (ii) acts or omissions not in good faith or which involve intentional misconduct or knowing violation of the law, (iii) a transaction from which such Member and/or Member-Manager derived an improper personal benefit, or (iv) acts or omissions for which indemnification is prohibited under the Florida Limited Liability Company Act, or (v) judgments, penalties, fines, and settlements arising from any proceeding by or in the right of the Company, or against expenses in any such case where such Member and/or Member-Manager shall be adjudged liable to the Company.

The indemnification provided in this Article shall not be deemed exclusive of any other rights to which a person indemnified may be entitled under any agreement, vote of Members, or disinterested Officers or otherwise, both as to action in the official capacity of such person and as to action in another capacity while holding such office, and shall continue as to a person, who has ceased to be an Officer or a Member and shall inure to the benefit of the heirs, executions and administrators of such person.

# Article XIV Real Estate Documents

All conveyances and mortgages of and leases relating to real property made by the Company shall be executed by a Member-Manager, and all releases of mortgages, liens, judgments, or other claims that are required by law to be made of record may be executed by a Member-Manager.

# Article XV <u>Amendment of Articles of Organization</u>

The Company reserves the right to amend, alter, change, or repeal any provisions contained in these Articles Of Organization in the manner now or hereafter prescribed by statute and all rights conferred upon Members herein are granted subject to this reservation.
