**AMENDED AND RESTATED  
ARTICLES OF ORGANIZATION OF  
THE VILLAS AT HERITAGE PARKE, LLC**

**(Changing name to The Villas at Heritage Park, LLC)**

Pursuant to the provisions of Chapter 608 of the Florida Statutes, the Articles of Organization for THE VILLAS AT HERITAGE PARKE, LLC (the "Company") filed with the Secretary of State of Florida on November 18, 2004 are hereby amended to change the Company's name to THE VILLAS AT HERITAGE PARK, LLC. The Articles of Organization as amended and restated shall read as follows:
