TO
ARTICLES OF ORGANIZATION
OF

The undersigned, for the purpose of amending the Articles of Organization of Laser Spine Institute, LLC, a Florida limited liability company, hereby makes, acknowledges, and files the following amendment to its Articles of Organization, pursuant to Section 608.411, Florida Statutes.


SECOND: The following amendment to the Articles of Organization was adopted by Laser Spine Institute, LLC:
